Why is this agency closing?

The proprietor of our agency in Leyburn has informed us that they wish to close the agency because they are merging with another firm and the YBS no longer fits with the new entity.

After careful consideration and review of customer usage, YBS has decided not to replace the agency in this location.

We understand this is disappointing for customers.

- Customers who have opened their account at another YBS outlet but live within 20 miles and have transacted at this agency within the last 12 months.

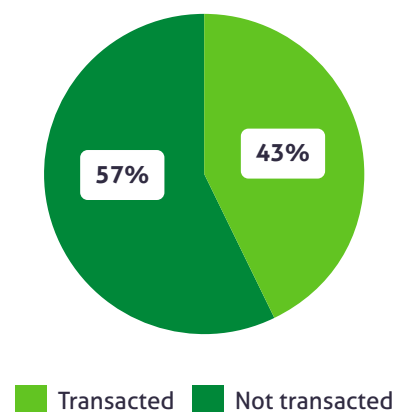
Why are we not replacing the agency?

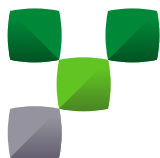
Leyburn customers in the last 12 months

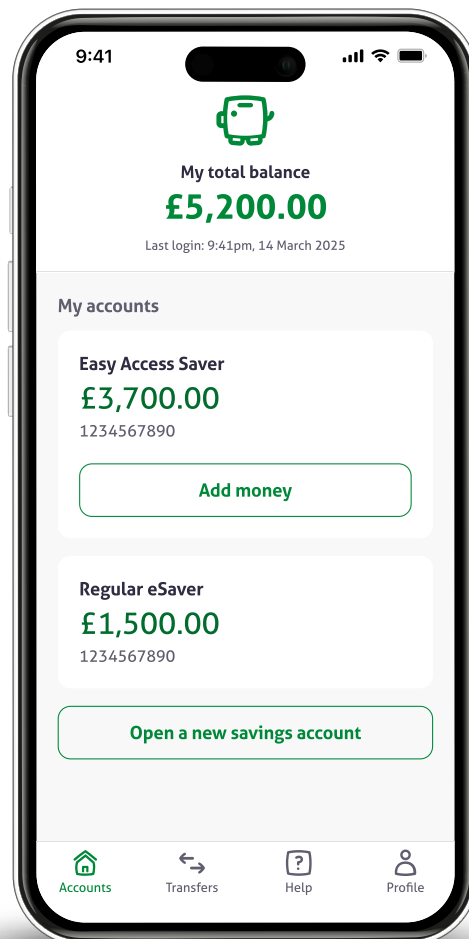
